WHAT ARE YOU WORKING ON?

- Investment opportunities: Through our network, we provide investors with the opportunity to invest in select start-ups in various formats, i.e., equity, blended equity, debt, etc., with the minimum investment value starting at US\$10,000, and the general raise on the platform ranging between US\$500k to US\$1m. ~300+ start-ups have applied to the network in the last 18 months and currently, GEN is in the advanced stage of completing investments in 3 start-ups working in the energy, water management and waste sectors.
- Massive Earth Summit April 2020: Being one of our largest events in South East Asia, The Massive Earth Summit, a 1 day event, showcases some of the leading start-ups involved in tackling pollution/climate change and also hosts various investors, policy makers, foundations and entrepreneurs, thus bringing various stakeholders together onto a single platform to discuss investment opportunities. The 2018 edition of the event witnessed participation from 300+delegates, 40 Speakers and had 3 Country showcases.
- Global Innovation Challenge: The Global Innovation Challenge crowdsources solutions, selects the best one, pilots the
 solution and rewards the best with an investment award. Going beyond just rewarding the solution, the best ones are
 mentored and receive support to raise a further round of capital, given the success of the pilot, thus amplifying the
 overall impact.

WHAT ARE YOU WORKING ON?

- Managing the Catalyst Fund for which an India chapter was launched: The Catalyst Fund is an inclusive fintech accelerator that supports early-stage start-ups in building accessible, affordable and appropriate solutions for underserved populations in emerging markets (focussed on the five strategic markets of Kenya, Nigeria, South Africa, India and Mexico) that aims to develop the innovation ecosystems around these entrepreneurs in order to unlock more capital at the early-stage, develop pathways for companies to scale through partnerships, and contribute to the start-up talent pipeline. The program provides flexible grants, bespoke venture-building support, and curated 1:1 connection with investors, corporate partners, market facilitators, and other stakeholders, to help start-ups bring innovative solutions to the market. Working from the ground up, we also captures insights from our acceleration work to offer resources and proof points around emerging innovations that can foster financial inclusion and financial health. Founded in 2016 with support from the Gates Foundation and JPMorgan Chase & Co, the fund managed by BFA has partnered with UKAid. Since our origin, we has accelerated 25 start-ups across 13 markets and look to accelerate another 30 companies in the next 3 years.
- Optimizing social benefits transfers in Bihar: Assisting the Government of Bihar in the assessment of the Direct Benefit Transfer (DBT) system implemented in the State, we assessed the existing framework and architecture of the government payment systems earlier this year and are developing a set of action items suggesting operational improvements to enhance efficiencies in Direct Benefit Transfers. As a result, beneficiaries of pensions, subsidies, and other special allowances will be able to receive their entitlements more easily, with lower wait-times and improved mechanisms to interact with and follow the government process. To achieve this, we are (i) undertaking an "as-is" study of short-listed schemes by the state government; (ii) providing best practices to re-engineer the e-Labharthi platform (an online platform for e-payments of subsidies); (iii) suggesting an optimal framework to develop a beneficiary grievance and citizen feedback mechanism; (iv) identifying cost-effective solutions to address last-mile delivery challenges; and (v) developing an M&E framework to monitor the progress of schemes to be DBT-ready. Our work with the Government has also helped guide discussions towards potentially developing a social registry for Bihar.

- Gender and Business Technical Assistance for SGBs: We work with SGBs in diverse sectors to help them solve business challenges with a gender lens. Our approach includes the design of gender strategies, actions and training suited for each business' stage of development and its priorities. Identifying the business case and the case for social impact lies at the core of this work (Example of this work can be found at A Business First Approach To Gender Inclusion)
- **Gender Landscape and Market Research:** We spearhead landscape research for investing with a gender focus, as well as market research to design gender-smart products and services for investors and financial institutions. Our research provides a springboard for institutions to shape their specific value propositions and services for women and womenled businesses. We identify the needs women entrepreneurs have, what others are already doing on gender, and the untapped opportunities to generate impact on gender (Example of this work can be found at Impact investing With A Gender Lens In Latin America)
- Gender Trainings Tailored to Diverse Audiences: With an audience including investors, financial institutions, SGBs, students and women entrepreneurs, our modules focus on (i) Gender 101 levelling knowledge around gender, gender norms, and the barriers that women face to entrepreneurship and access to finance (ii) Business cases Showing how advancing gender inclusion can simultaneously enhance business performance and promote social outcomes.

WHAT ARE YOU WORKING ON?

• The Program to Improve Private Early Education (PIPE): The program aims to replace rote learning with activity-based learning in all 300,000 Affordable Private Schools (APSs) in India and to give every low-income child the strong education foundation they deserve. PIPE is building a demand for parents to seek activity-based learning, and is assisting 8 private companies or Partners (Chippersage, Chrysalis, Hippocampus, Karadi Path, Kreedo, Next Education, Vikalp, and 321 Foundation) in supplying high-quality activity-based learning to APSs. PIPE works with its partners to help them recognize the business opportunity and address the challenges in serving the APS market. Once partners understand the economic opportunity in the APS market, they educate parents on the benefits of this method, which drives demand to expand our services to millions of children. Since 2015, FSG has worked closely with APS administrators, teachers, parents and ABL solution providers to develop an extensive understanding of the Indian APS market and effectively improve the delivery of activity-based learning. As of 2019, PIPE's 8 partners are serving 650+ APSs and providing 74,000+ children access to activity-based learning. A recent assessment showed that Sr. KG children in PIPE APSs had 51% better learning outcomes than Sr. KG children in control APSs
